- The tenderer shall be of "Two Bid Type". All documents in two separate envelope super-scribed as "technical Bid" i.e marked as "A" and Price Bid marked as "B" shall be furnished in a closed cover. Both the closed envelopes shall be kept in another envelop, which will be super-scribed as "Tender for Cleaning & Sanitation work (24 hrs X7) of Wards & Out House cleaning of SCB Medical College Hospital, Cuttack".
- 2. The Tendere should provide cleaning and sanitation work in all the wards and in the premises 4 times in 24 hours and when required in respect of floor area along with common bath, common urinals, commonlatrine, corridor, wash basin and mirror of the different departments of SCBMCH, Cuttack in proper hygienic condition using detergent and floor moping thoroughly. Furniture, tube lights, bulbs, fans, air conditioners should be thoroughly cleaned and kept clean all times and the roof wall and corridor should be kept clean. Details regarding cleaning requirement is annexed at Annexure-1
- 3. The selected party will clean the outer area of the building including road and drains excluding drains of quarters and colony areas and desalting of drain by the Authority.
- 4. The tenderer should have a branch office in Cuttack and detail address should be mentioned in the tender with mobile number and Email address.
- 5. Quality of the materials should be used in cleaning and sanitation work shall be of highly hygienic standard. The brand of materials should be mentioned.
