CONDITION 3: General Terms and Conditions

- 2. The bidder and mess-cum-canteen workers have to behave politely with all staff and students.
- 3. Smoking and intoxication (drug, alcohol, Gutkha, Tobacco, etc.) is strictly prohibited.
