- 2. The tenderer must be enclosed the copy of the money receipt in support of purchase of tender papers or a bank draft amounting to Rs.500/- in favour of the "The Director-cum-Medical Superintendent, Mental Health Institute, SCB Medical College Hospital, Cuttack", when the tender form will be downloaded from the website at the time of submission of tender paper
- 3. The Bids shall be opened in presence of the tenderers or their authorized representatives. The representative to be present at the time of opening of tender should produce an authorization letter from the bidders.
