Any tender received after the due date & time will be rejected / returned to the sender unopened. The tenders will be received through / Speed Post/Regd Post only. No tender paper submission through the person/persons by hand is accepted.
- 1.2 The bidder(s) are to submit their tender in separate sealed covered envelops for technical bid and commercial bid by super scribing Cover "A" (Technical Bid) & Cover "B" (Price Bid) and both the covers should be put into a third Cover, which should be super scribed as "Tender for the Annual Comprehensive Maintenance Contract (CAMC) of Manifold Room, Medical Gas Equipment and Central Medical Gas Pipeline System for 3yrs at SCB MEDICAL COLLAGE & HOSPITAL, CUTTACK. This will also include testing, packing, transportation, scheduling of transportation, transit insurance, delivery at sites, unloading, storage, job site storage, insurance, installation any other services associated with the delivery of the equipment and materials providing warranty of services and operation and maintenance of other related equipment / items required for complete installation. The successful bidder will assume full responsibility of the complete system until final acceptance.

#### **ELIGIBILITY CRITERIA**

- 2.1 Manufacturing units eligible to participate in the tender provided, they have
  - (i) Valid manufacturing license/import license
  - (ii) Tenderer have must be proof of supply, installation and commissioning of Medical GAS pipeline system at any Govt. organization / PSU Hospitals //Corporate Hospitals(Not less than 100 Bedded)Bidder Must be produce Performance certificate in support of that from the user in last 3 years in odisha only for the year 2018-19 & 2019-20 & 2020-21)
  - (iii) Manufacturing unit who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt, organization is not eligible to participate in the tender for that item during the period of blacklisting.
  - (iv) The Bidder Must be Registered Service Center For MGPS Last 5 Year In Odisha only.

  Cover -B (Price Bid) will be opened only of the tenderers who qualify in Technical Bid (Cover A) and product is as per tender specification.
- 4.1 The tender format (Price Schedule) in duplicate in the prescribed form (as per Annexure –II), hard copy and must be submitted in Cover-B. The price of the item should be quoted inclusive of excise duty, insurance, packing, forwarding, freight (door delivery), installation, Annual Maintenance Contract (CAMC), if any and the turnkey job in a separate column. In case of difference in words and figures, words will be taken into consideration for evaluation.
- N.B: Valid means the certificate should be valid on or beyond the date of opening of tender (Cover-A).
- 4.2 The date of opening of Cover "B" (Price Bid) of the successful bidders will be intimated later on.

## 5. Earnest Money Deposit:

### 6. PRICE EVALUATION:

- 1. Tenderers who technically qualify will be evaluated only.
- 2. The cost of Comprehensive Annual Maintenance Contract (CAMC) of Manifold Room, Medical Gas Equipment and Central Medical Gas Pipeline System for 3yrs (inclusion of the excise duty, transportation, insurance, packing & forwarding and the estimated cost to make functional of the existing medical gas pipe line system together will be evaluated and the lowest bidder will be selected.
- 3. The cost of the repair to make all the Manifold Room, Medical Gas Equipment and Central Medical Gas Pipeline System should be mentioned separately in the Annexure-B.

### 7. Payment:

- 1. 100% payment shall be made after submission of invoice duly certified by the concerned officer/installation & demonstration certificate/s and service report of the repair work.

#### TERMS AND CONDITIONS PRICE:

Only the price quoted by the Supplier(s) in his / their financial proposal will be the price for payment and no other price escalation will be allowed at any circumstances.

#### TERMS FOR PAYMENT.

100% Payment will be released to the supplier on receipt of repair invoice and installation certificate (that it is working) from the consignee.

The approved value of CAMC(Compressive Maintenance Contract) payment will be made on half yearly basis year wise after signing the CAMC agreement

- A. Before release of payment the supplier has to submit the signed agreement, turnkey job to the consignee.
- B. The payment of CAMC will be made on six monthly basis period and signing of the CAMC agreement.

#### TURNKEY JOB:

The external power supply will be provided by the purchaser but the internal wiring and electrical fittings inside the room for installation & commissioning of the equipment and accessories will be provided by the supplier without any extra cost (This cost is to be included in the cost of turnkey). Usage of the equipment every day and for calculation of up-time.

#### **INSTALLATION AND DEMONSTRATION:**

The installation and demonstration of the equipment shall be done by the Supplier(s) at free of cost at the installation site of the respective institutions.

#### TRAINING:

Supplier(s) shall impart adequate training to 2 doctors and 2 technicians at the site at the Supplier(s) cost.

#### INCIDENTAL SERVICES:

The Supplier(s) shall abide by the terms and conditions under incidental services & the installation of Instrument / Equipment at the destination point (Door Delivery) of consignee and demonstrate the machine in working condition to the receiving authority.

Furnishing of tools required for assembly and / or maintenance of the supplied Instruments / Equipment.

Performance or supervision or maintenance and / or repair of the supplied Goods, for a period of two (1) years i.e. the warranty period, provided that this service shall not relieve the Supplier of any warranty obligations under this contract.

The successful supplier shall replace any part or whole system as may be necessary in the event of damage during transit or found damaged on arrival or during installation of the system or if found not in conformity to the specifications at his / their own cost.

The tenderers shall clearly mention the price of the instruments / equipment inclusive of warranty for a period of 1 (one) years commencing from the date of installation. The tenderers shall submit undertaking for C.A.M.C (Comprehensive Annual Maintenance Cost) for a period of 3 (three) years from 2<sup>nd</sup> year onwards duly signed by authorized signatories for the execution at appropriate time (Annexure - V &l).

#### **SPARE PARTS:**

The supplier will provide all the spare parts, repairing & maintenance by its trained personnel after the warranty period (1 year) during the CAMC period.

## **COMPREHENSIVE WARRANTY:**

This warranty shall remain valid for One (1) years from the date of installation& commissioning of the GPMS/ item & must be submitted at the time of installation to the consignee with a photocopy to the purchaser.

The warranty will cover all the parts of the machine or item and any replacement or repair required within the warranty period will be provided by the supplier free of cost at the destination point (Installation point). The supplier will take back the replaced parts / goods at the time of their replacement. No claim whatsoever shall be on the purchaser for the replaced parts / goods thereafter. No traveling allowances or transportation cost will be paid by the purchaser during warranty period.

The Supplier warrants that the Goods supplied under this contract are new, unused, of the most recent or current models and they incorporate all recent improvements in design and materials (even if the advanced facilities are not mentioned in our product specification). The Supplier further warrants that all Goods supplied under this contract shall have no defect arising from design, materials or workmanship (except when the design and / or material is required by the Purchaser's Specifications) or from any act or omission of the Supplier, that may develop under normal use of the supplied Goods in the conditions prevailing in the place of final destination.

The Purchaser / consignee shall promptly notify the Supplier in writing / Fax / Telephone of any claims arising under this warranty.

Upon receipt of such notice, the Supplier shall with all responsible speed will repair or replace the defective goods or parts thereof without cost to the purchaser to maintain its UP TIME offered in the beginning of purchase otherwise penal provisions shall apply if the supplier fails to keep up its UP TIME.

## **GOVERNING LANGUAGE:**

The contract shall be written in English language. English language version of the contract shall govern its interpretation. All correspondences and other documents pertaining to the contract which are exchanged by the parties shall be written in English.

#### DELIVERY OF DOCUMENT

Four (4) copies of the Supplier invoice / bills showing purchase order number, good's description, quantity, unit price, total amount with stock entry certificate by the consignee.

Photocopy of the Insurance Certificate if any (The Original Certificate is to be given to the Consignee).

Attested Photocopy of Manufacturer's / Supplier's warranty certificate. (The original warranty certificate is to be submitted to the consignee at installation point).

#### INSURANCE

For delivery of goods at site, the insurance shall be obtained by the Supplier(s) in an amount equal to 110% of the value of goods from "Warehouse" (final destination) on "All Risks" basis including natural calamities.

### PACKAGING:

The supplier shall provide such packaging of the goods as is required to prevent their damage or deterioration during transit to their final destination. The packaging shall be sufficient to withstand without limitation rough handling during transit and exposure to extreme temperature, salt and precipitation during transit and upon storage. All primary packaging containers which come in contact with the item should strictly protect the quality and integrity of the Instruments &Equipments. Packing case size and weights should be taken into consideration, in case of remoteness of final destination and the absence of heavy handling facilities at all points in transit.

The packaging marking shall show the description of quantity of contents, the name of the consignee and address, the gross weight of the packages, the name of the supplier with a distinctive number of mark sufficient for purposes of identification. Each package shall contain:

- ii. nomenclature of the goods
- iii. schedule of parts for each complete equipment giving part number with reference to assembly.

- Area Valve Box Service Units
- Copper pipelines
- Medical Vacuum System Vacuum pumps, Medical Air Compressors, Control panel, Receiver, Filters etc.

## **Terms & Conditions**

- The Contract is valid for a period of three years with renewal of every year (Their presence in the campus is highly essential (24x7) considering the performance of the approved agency from the date of commencement of contract after signing by both the PartiesThe First Party's Engineer will provide service to the Second party i.e. four preventive maintenance visits during contract period to give service for the necessary parts of the instruments and ensure that the instruments are working satisfactorily.
- In the event of any malfunction, the first party's personnel, including their service Engineer, if required will make two or more emergencies numbers of visits.
- Any damage due to misuse, neglect, accidental damage or damage caused by fire, riot, flood or other acts of nature will not come under CAMC contract.
- CAMC will not be covered if any instrument is tampered or altered or serviced by any individual or agency not authorized by the company.
- The complaint lodged by the hospital authority shall be attended/rectified by the vendor within 24x7hrs (working hours) from time of receiving the complaint & rectification should be done within 48hrs (Working hrs, Sundays & Holidays are excluded).
- If any Natural Calamities or Accidental Incident we are not held responsible.
- CMC: The tenderer shall also commit to provide offer for CMC (Labour + all spare) for the next three (3) years after one year of warranty. No extra cost will be paid other than the CMC cost for functioning of the item during this period. The supplier will provide one (1) preventive maintenance in every six months in a year during the period of CMC and any number of on call visit against complain at free of cost. The necessary maintenance log book has to be maintained by the supplier.
