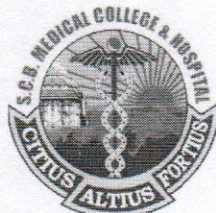



**TERM & CONDITIONS FOR ACCEPTANCE OF TENDER FOR**  
**FOOD/REFRESHMENT ITEMS FOR DEPARTMENT OF**  
**TRANSFUSION MEDICINE**

01. The EMD Rs 3,000/- only in shape of demand draft in favor of superintendent of SCB College & Hospital Cuttack Medical. The EMD money of the successful bidder will be refunded after successful completion of supply.
02. Reputed firm/ agencies having valid GST registration are eligible to participate in the bidding process and quote for all the items
03. Sealed covers containing the bid in the prescribed form to be submitted in sealed covers. The cover should be mentioned as for "BID FOR SUPPLY OF FOOD / REFRESHMENT ITEMS OF SCB MEDICAL COLLEGE & HOSPITAL CUTTACK "
04. The rate should be quoted in Indian currency only both in words & figures against each item. However the rate quoted in words shall prevail if there is difference between words & figures.
05. The price and tax component should be mentioned separately & the total amount should be within Rs. 50/-.
06. The term and conditions and the quoted price of the bids shall remain valid for a period of 12 months from the date of agreement or the extended period if any whichever is later.
07. The successful bidder have to submit the security deposit of Rs.3,000/- in shape of BD/ BG in favour of Superintendent SCB MCH, Cuttack within 15 days from receipt of the work order. The bidder has also make an agreement with non-judicial stamp paper worth Rs.100/-
08. The authority reserve right to cancel all tender, partly or full, without assigning any reason thereof.
09. The authority / Committee is not responsible for any postal delay.
10. The rate quoted in the tender will remain unchanged during the valid period.
11. Any dispute arising between the supplier and purchaser will be subject to Cuttack jurisdiction only.

### **DESCRIPTION OF FOOD / REFRESHMENT ITEMS**


- a) Item: Flavored milk  
Brand: Amul cool, Omfed  
Quantity: Amul Cool (Pista flavor) 180ml, Amul Cool (chocolate flavor) 180ml in plastic bottle, Omfed (Pista flavor) 180ml, Omfed (chocolate flavor) 180ml in glass bottle as sealed and packed by manufacturer.
- b) Item: Chocolate Biscuits  
Brand: Britannia Good day, Parle Happy Happy, Sun feast Biscuit  
Quantity: Good day, Happy Happy & Sun feast biscuit 75 gm each as sealed and packed by manufacturer.
- c) Item: Cream cake  
Brand: Lotto Choco-pie, Britannia cake, Sun feast cake  
Quantity: Lotto Choco pie 28gm, Britannia cake 35gm & Sun feast cake 25gm as sealed and packed by manufacturer.

(All rates to be written in figures as well as in word. In case the entries for figures and for word vary, the entry in word will be accepted.)

### **SPECIAL NOTE**

1. All items (a, b & c) are to be given together in individual eco-friendly disposable bags of adequate microns as permitted by local Govt. authorities.
2. The individual packages kept in disposable bags are to be packed in cardboard cartons. (20 packages in one carton).
3. Average requirement will be 60 packets in three cartons per day. However, this number may vary on special occasions and the supplier would be informed earlier regarding the variable quantity.
