The Tender cost fee of Rs. 500/- (**Non-refundable**) by way of separate Demand Draft drawn in favour **Superintendent, S.C.B. Medical College & Hospital, Cuttack** payable at **Cuttack** should be enclosed along-with the Bid. The Bidders should specifically superscribe, "**DOWNLOADED FROM THE WEBSITE**" on the top left corner of the outer envelope containing the Bid. The terms and conditions of the tender can also available in the Non-Technical Store Section, O/o Supdt. on depositing of money receipt worth Rs. 500/- in shape of cash in the Accounts Section (Govt.) of this office from 4.11.2022..... within the stipulated period. The Tender cost fee and the EMD amount should be submitted separately. In case of any bid amendment and clarification, responsibility lies with the bidders to collect the same from the website / Office of the undersigned before last date of sale of tender document. The Superintendent, S.C.B. Medical College Hospital Cuttack shall have no responsibility for any delay/omission on part of the bidder.

The tender paper will be rejected if the bidder changes any clause or Annexure of the bid document downloaded from the website.

- II) The interested tenderers may inspect the old Instruments, equipments, furnitures, library books, linen & others available in the different departments of SCB Medical College Hospital, Cuttack during working days from 4.11.2022 between 11.00 A.M. to 4.00 P.M.(within the stipulated period). For any clarification, they may contact the concerned I/c/ Nodal Officer, Condemnation Committee/Store Medical Officer, SCB MCH, Cuttack before submission of tender.

- III) Sealed tenders superscribing on the envelop "**TENDER FOR AUCTION SALE OF OBSOLETE INSTRUMENTS, EQUIPMENTS, FURNITURES, LIBRARY BOOKS, LINES & OTHERS**" should reach the undersigned on or before 5.00 P.M. of Dt. 25.11.2022..... in full phased form **through Speed Post / Regd. Post only** which will be opened on the next working day at 11.30 A.M. in presence of the tenderers or their authorized representatives. The bidder must have to be present at the time of opening of the bid

documents. If the tenderer fails to present at the time of opening the tender, the bids of the same parties/firms will be treated as cancelled.

- IV) The Tenderer should enclose Bank Draft @ Rs.10,000/- (Rupees Ten Thousand Only) in favour of the Superintendent, SCB Medical College Hospital, Cuttack on any Nationalized bank at Cuttack towards EMD (non-interest bearing) along with their tender, without which the tender will be rejected.
- V) At the time of selection, the major item selected (H1) bidders will be asked to negotiate to upgrade their offers for lifting all the condemned items with H1 price offered by the minor items selected bidders.
- VI) The condemned articles shall be handed over to the successful tenderer only after receipt of it's full value within the stipulated period as per the tender conditions.
- VII) The successful highest bidder will deposit the security deposit Rs. 50,000.00 (Rupees Fifty thousand) only till completion of auction sale process. If successful bidder violate the terms & conditions at any interval of the sale process, the security deposit and EMD amount will be forfeited.
- VIII) The successful bidder will lift the condemned scrap articles after deposit of full auction value in the store section on proper weighment.
- IX) The EMD of all unsuccessful tenderer will be refunded after finalization of the tender.
- X) The EMD may be forfeited-
- a) If a tenderer withdraws its tender during the period of interval between deadline of submission and finalization of the tender.
 - b) In case of successful tenderer, if the tenderer fails to execute the work order.
- XI) The condemned articles will be handed over to the successful tenderers after proper receipt of the deal at the places where it is lying. It will be the responsibility of the successful tenderer/ purchaser to dismantled/ transportation/weighing cost and take delivery of the condemned articles to their destination by their own arrangement.
- XII) The tenderer should sign and put his seal on each page of the tender document i.e. up-to-date GST Regdn. Certificate, PAN Card, Aadhar Card and submit the entire set along with the required amount of EMD in sealed envelop.
- XIII) Conditional & Incomplete tenders shall be rejected.
