The tender documents can be obtained from the store section (N.T.S.K. SECTION) on production of money receipt from 11.00 AM to 4.00 PM. The last date of submission of tender paper on or before Dt. 1.7-01-2-3... by 4 P.M. and it will be opened on Dtd. 1.7-01-2-3... at 12 NOON.
- 2. The Bidders may also download the Tender Documents directly from the WEBSITE available at "http://www.scbmch.in" from Dt. 17-12-22. The Tender cost fee of Rs. 500.00 (Rupees Five hundred) (Non-refundable) only by way of separate Demand Draft drawn in favour Superintendent, S.C.B.
