Eligible candidates are invited for <u>walk-in interview</u> for selection of the posts of Senior Residents (SR), Tutors in different disciplines in SCB MC, Cuttack on Dt. 12.02.2024. The applicant must have acquired the required qualification for the post applied. The engagement shall be purely temporary for a period of one year. The in-service candidates will be entitled to draw their usual salary and the direct candidates will be paid consolidated amount as notified by Govt. from time to time. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. The reporting time for the above walk-in-interview is from 10-11 AM.

1. Available vacancy:

The provisional vacancy will be notified in the website (https://scbmch.in/).

2. Reservation:

Vacancy based reservation will be applicable as per the guidelines of Govt. of Odisha Health & FW Dept. Resolution No. 18582/H&FW Dt. 13.08.2020.

3. Age:

Must be less than 45 years as on the date of joining in the post.

4. Eligibility and Qualifications for Senior Residents:

- 4.1.For the post of Senior Residents (non-academic) the candidate must possess MD/MS/DNB or any Equivalent Degree in concerned discipline applied for or as prescribed by NMC in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022" notified or amended from time to time in force.
- 4.2. For the post of Senior Resident, candidates with Post Graduate degree in concerned subjects will be preferred. If candidates with Post Graduate not available, then Medical MSc. in concerned subjects with PhD will be taken into consideration.
- 4.3. All Qualifications as on the date of interview shall be considered.

 Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be asunder:

HSC/Matriculation- 20% of total percentage of marks secured.

Intermediate Science- 20% of total percentage of marks secured.

MBBS examination- 60% of total percentage of marks secured.

In case of candidates who have passed PG in 2016-17 and afterwards, MBBS/M.Sc. Examination -30%, PG -30%

One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

- 4.4. Other eligibility conditions:
 - 4.4.1. The candidate must be a citizen of India.
 - 4.4.2. The candidate must not be continuing or have completed the tenure of three years as Senior Resident in any Govt. Medical College of the State (undertaking should be submitted by the candidates).
 - 4.4.3. The candidate whose service as Senior Resident has been terminated by any Govt. Medical College in the state for whatsoever reason will not be considered for reengagement (undertaking should be submitted by the candidates).
- 5. Eligibility and Qualifications for Tutor:
 - 5.1. For the post of Tutors as prescribed by NMC in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022" from time to time in force.
 - 5.2. For the post of Tutors candidates with Post Graduate degree in concerned subjects will be preferred over the MBBS candidates. If candidates with MBBS not available Medical MSc. in concerned subjects with PhD will be taken.
 - 5.3. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total percentage of marks secured.

Intermediate Science- 20% of total percentage of marks secured.

MBBS examination- 60% of total percentage of marks secured.

One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

- 5.4. All Qualifications as on the date of interview shall be considered.
- 5.5.Other eligibility conditions:
 - 5.5.1. The candidate must be a citizen of India.
 - 5.5.2. The candidate must not be continuing as Tutor in any Govt Medical College of the State.
 - 5.5.3. The candidate whose service as Tutor has been terminated by any Govt. Medical College in the state for whatsoever reason will not be considered for reengagement.
- **6. Tentative Programme:** The programme shall be notified in the website of SCB MC, Cuttack.

7. Selection Process:

Without pre-registration the candidates will not be allowed to participate in walk in interview. Eligible candidates shall appear personally before the Convener as per schedule and submit the application form attached to this advertisement duly filled in and self-attested photocopy of required documents and two color passport photographs. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited through Demand Draft in favor of the SCB Recruitment Committee payable at SBI SCB MC Campus Branch, Cuttack. Copy of the bank transaction receipt is to be submitted during document verification.

After successful verification of the documents a provisional merit list shall be prepared and notified inviting any grievance to the merit. The grievances if any will be examined and a final merit list will be notified. The candidates will submit the signed option form for confirmation of their acceptance of allotment. The appointment order will be uploaded in website. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier.
