- (v) Other terms and conditions as mentioned in the Govt. Resolution No.18582/H Dt.13.08.2020 shall be applicable.


Terms and conditions for In-service Candidates:

(iii) The selected candidates are requested to join immediately before the Prof. & HOD of their concerned Department after being relieved from their present place of posting.


(iv) Other terms and conditions as mentioned in the Govt. Resolution No.18582/H Dt.13.08.2020 shall be applicable.






