- (iv) Other terms and conditions as as per the Clause-9 of Health & FW Resolution No.8967/H Dt.25.04.2022 shall be applicable.


The selected candidates are requested to join within 7 days before the Prof. & HOD of their concerned Department.

Terms and conditions for In-service Candidates:


- (i) The Regular In-service candidates shall be allowed to draw salary from the post against which they are posted.
- (ii) For In-service Assistant Professors :- Salary, Pay Protection and other service conditions shall be governed as per provisions of Health & Family Welfare Department Letter No.6547/H Dt.04.03.2017.
- (iii) The terms and conditions relating to Job responsibility and etc. of Asst. Professor on deputation basis will be guided as per the Clause-9 of Health & FW Resolution No.8967/H Dt.25.04.2022.

(iv) The engagement shall be purely temporary and on year to year tenure basis and may be for a maximum period of 04 years subject to satisfactory performance or till appointment of Doctor as Asst. Professor on regular basis through OPSC, whichever is earlier.




