**RECRUITMENT FOR FILLING UP OF VACANT POSTS OF
ASSISTANT PROFESSOR IN SCB MC, CUTTACK**

Eligible candidates are invited to attend the **Walk in Interview** for the post of Assistant Professor in SCB Medical College, Cuttack on Dt. 12.03.2024 contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for one year renewable for a maximum period of four years. The regular and contractual Assistant Professors of any Govt. Medical College of the state, VIMSAR, Burla or AHPGIC Cuttack or PGIMER & Capital Hospital, Bhubaneswar are not eligible to apply. The Assistant Professors whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

1. AVAILABLE VACANCY

The vacancy is provisional and the detailed vacancy shall be notified in the website (<https://scbmch.in/>).

2. ELIGIBILITY:

2.1 The candidate must be a citizen of India.

2.2 Qualification:

2.2.1 ELIGIBILITY & QUALIFICATION FOR ASSISTANT PROFESSOR

2.2.2 The candidate must possess MD/MS/DNB or equivalent degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges and/or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022" as amended from time to



time. Candidates having MSc (Medical Subject) with PhD in pre and para clinical subject (approved by NMC or MCI) may be considered if sufficient candidate with PG degree / DNB are not available and subject to the limitations as may be prescribed by NMC / MCI from time to time. The candidates having DM/MCh/DNB or equivalent degree are not required any additional teaching experience.

2.2.3 Must have registered himself/herself under any Central / State Medical Council after obtaining the degree (Permanent Registration).

2.2.4 The above qualifications must have obtained on or before the date of interview.

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Interested candidates shall fill up the google form in the link <https://docs.google.com/forms/d/e/1FAIpQLScYdEOpmYUu4yqAq75eEvg-ecxvdov6OPvlworPNL99EcZyA/viewform?vc=0&c=0&w=1&flr=0> as a pre-registration process to participate in the walk-in interview latest till **12 noon of 11.03.2024**. Without pre-registration the candidates will not be allowed to participate in walk in interview. Eligible candidates shall appear personally before the Convenor in the venue as per programme notified, at 10.00 AM on Dt.12.03.2024 and submit the application form attached to this advertisement duly filled in and self-attested photocopy of required documents and two-color passport photographs. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited through Demand Draft in favor of the SCB Recruitment Committee, SCB MC payable at SBI SCB MCH Campus Branch, Cuttack. Candidates applying for multiple subjects should submit bank drafts and application form for each subject separately.

Original copy of the bank draft is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of SCB Medical College, Cuttack.



N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. Physical presence of the candidate is mandatory at the time of document verification. No authorization will be entertained.

5. PROCEDURE OF SELECTION

- a. Selection will be strictly on the basis of merit list prepared as per advertisement.
- b. The Selection of Asst. Professor will be strictly on the basis of merit list prepared on basis of career marks as these are purely temporary and tenure-based engagements and done only to meet the exigency, on regular recruitment of faculty by the OPSC or on completion of the contractual tenure, whichever is earlier, they shall be disengaged. Weightage for different examination shall be as under:

HSC/Matriculation-	20% of total percentage of marks secured
Intermediate/+2 Science-	20% of total percentage of marks secured
MBBS/M.Sc. examination-	60% of total percentage of marks secured
In case of candidates who have passed PG in 2016-17 and afterwards,	
MBBS/M.Sc. Examination –	30%, PG – 30%

One mark will be deducted from the total career mark for each extra attempt taken to pass the examination.

In case of tie it will be resolved as follows:

- i. The candidate securing more mark in MBBS/M.Sc. as the case may be shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. In case of tie, it will be resolved as follows: In case of tie the elderly, candidates shall be placed higher in rank to the younger.”



- d. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- e. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. All communication shall be made through the website of SCB MC, Cuttack i.e., <https://scbmch.in/> No Postal/ personal communication will be entertained.
- g. Engagement will be on the basis of merit. Appointment/ Engagement order shall be uploaded in the website. The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order. The in-service candidates shall join after obtaining the relieve order from Government.

6. TERMS AND CONDITIONS


All the terms and conditions as per Govt. letter issued from time to shall be applicable.

- a. The Contractual Assistant Professors are entitled for remuneration of Rs. 1,20,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt letter No. 9684/H Dt 02.05.2022.
- c. For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one month prior notice from either side.
- d. Selected candidates have to register themselves in Odisha Council of Medical Registration within one month and sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.04.2022.
- e. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.

- iii. H.S.C./ Equivalent Certificate in support of age;
- iv. +2/ Equivalent Examination Certificate;
- v. MBBS/MD/MS/DNB/MSc with PhD Pass degree Certificate;
- vi. Mark sheets in support of all the aforesaid examinations (i.e. from H.S.C. onwards) passed including fail marks if any.
- vii. Certificate of Registration for Medical Qualifications from Odisha Council of Medical Registration (valid up to date for UG &PG);
- viii. Chance Certificate of MBBS/ MD/MS/DNB/ MSc is mandatory.
- ix. Teaching Experience Certificate as SR/Tutor.
- x. Photo ID issued by the Govt. authorities i.e. Passport/PAN /Voter /AADHAAR card.
- xi. If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.


