
RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASSOCIATE PROFESOR / ASSISTANT PROFESSOR / TUTOR IN SCB MC, CUTTACK

Eligible candidates are invited to attend the Walk in Interview for the post of Associate Professors/ Assistant Professor/ Tutor in SCB Medical College, Cuttack on Dt. 13.05.2024 contractual/deputation basis to meet the Minimum Standard Requirements (MSR 2020) of NMC. The details of eligibility criteria/ vacancies/ etc are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for one year renewable for a maximum period of four years for the post of Associate Professor & Assistant Professor. For the post of Tutor, the engagement shall be purely temporary and for one year. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHPGIC Cuttack, or PGIMER & Capital Hospital, Bhubaneswar either on contractual /deputation basis are eligible to apply for the next higher post only. The regular faculties of any Govt. Medical College of the state, VIMSAR, Burla or AHPGIC Cuttack or PGIMER & Capital Hospital are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years. The reporting time for the above walk-in-interview is from 10-11 AM.

2. ELIGIBILITY:

- 2.1 The candidate must be a citizen of India.
- 2.2 Qualification:

2.2.1 ELIGIBILITY AND QUALIFICATIONS FOR TUTOR:

- 2.2.2 For the post of Tutor as prescribed by NMC in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022" from time to time in force.
- 2.2.3 For the post of Tutor, candidates with Post Graduate degree in concerned subject will be preferred over the MBBS candidates. If candidates with MBBS not available Medical MSc. in concerned subject with PhD will be taken.
- 2.2.4 Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total percentage

20% of total percentage of marks secured.

Intermediate Science-

20% of total percentage of marks secured.

MBBS examination-

60% of total percentage of marks secured.

- 2.2.5 One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.
- 2.2.6 All Qualifications as on the date of interview shall be considered.
- 2.2.7 Other eligibility conditions:
- 2.2.8 The candidate must be a citizen of India.
- 2.2.9 The candidate must not be continuing as Tutor in any Govt Medical College of the State.
- 2.2.10The candidate whose service as Tutor has been terminated by any Govt. Medical College in the state for what so ever reason will not be considered for reengagement.
- 2.2.11 Age: Must be less than 45 years as on the date of interview.

2.1.1 ELIGIBILITY & QUALIFICATION FOR ASSISTANT PROFESSOR

- 2.1.2 The candidate must possess MD/MS/DNB or equivalent degree in the concerned discipline from any MCI/NMC approved/recognized/permitted Medical Colleges and/or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022" as amended from time to time. Candidates having MSc (Medical Subject) with PhD in pre and para clinical subject (approved by NMC or MCI) may be considered if sufficient candidate with PG degree / DNB are not available and subject to the limitations as may be prescribed by NMC / MCI from time to time. The candidates having DM/MCh/DNB or equivalent degree are not required any additional teaching experience.
- 2.1.3 Must have registered himself/herself under any Central / State Medical Council after obtaining the degree (Permanent Registration).
- 2.1.4 Must have one year of Teaching Experience Certificate as SR/Tutor in the concerned subjects after completion of PG Course.
- 2.1.5 The above qualifications must have obtained on or before the date of interview.
- 2.1.6 The Selection of Asst. Professor will be strictly on the basis of merit list prepared on basis of career marks as these are purely temporary and tenure-based engagements and done only to meet the exigency, on regular recruitment of faculty by the OPSC or on completion of the contractual tenure, whichever is earlier, they shall be disengaged. Weightage for different examination shall be as under:

- ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- 2.1.7 In case of tie, it will be resolved as follows: In case of tie the elderly, candidates shall be placed higher in rank to the younger."
- 2.1.8 **AGE LIMIT:** The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

2.1.9 **ASSOCIATE PROFESSOR**

- 2.1.9.1 Must have Academic Qualification as prescribed by MCI from time to time in force. Teaching experience for such number of years as Assistant Professor in the subject in the recognized Medical College, with minimum of such numbers of Research Publication, during the tenure of Assistant Professor or any such other eligibility criteria, as may be prescribed by NMC/MCI as the case may be from time to time.
- 2.1.9.2 The requisite experience and other requirements for equating Consultant or Specialist as "Associate Professor" (after possessing Post Graduate Medical Degree in the subject) shall be prescribed by NMC/ MCI from time to time in force.

- 2.1.9.3 Must have teaching experience of minimum four (04) years as Assistant Professor in the concerned discipline in any MCI/NMC permitted / recognized institute with at least two Research Publications as per NMC/MCI guidelines / OMES rules 2021 in force.
- 2.1.9.4 In case of non-medical teacher, the candidate must possess the PhD degree or any other qualification in the concerned subject as may be prescribed by NMC/MCI as the case may be from time to time.
- 2.1.9.5 Must have valid up to date medical registration along with registration of additional qualifications under any State Council of Medical Registration (as the case may be) after obtaining the degree.
- 2.1.9.6 Must have completed Basic Course in Medical Education from institution designated by NMC.
- 2.1.9.7 Must have completed Basic Course in Biomedical Research.
- 2.1.9.8 All qualifications as on the date of interview shall be considered.
- 2.1.9.9 **Selection Process:**Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of the candidate:-
