Terms and conditions for In-service Candidates:


- (i) The Regular In-service candidates shall be allowed to draw salary from the post against which they are posted along with the additional incentive as notified by Govt. for the said post, shall also be applicable.
- (ii) The engagement shall be purely temporary for a period of one (1) year.
- (iii) The selected candidates are requested to join immediately before the Prof. & HOD of their concerned Department after being relieved from their present place of posting.
- (iv) Other terms and conditions as mentioned in the Govt. Resolution No.18582/H Dt.13.08.2020 shall be applicable.
