Terms and conditions for Contractual Candidates:

- (i) The Contractual candidates shall draw the remuneration against the post in which they are posted and remuneration as may be notified by the Govt. from time to time shall be applicable.
- (ii) Any additional incentive as may be notified by Govt. for the said post, shall also be applicable.
- (iii) The engagement shall be purely temporary and on year to year tenure basis and may be for a maximum period of 04 years subject to satisfactory performance or till appointment of Doctor as Asst. Professor on regular basis through OPSC, whichever is earlier.

(iv) Other terms and conditions as per the Clause-9 of Health & FW Resolution No.8967/H Dt.25.04.2022 shall be applicable.

The selected candidates are requested to join within 7 days before the Prof. & HOD of their concerned Department.

Terms and conditions for In-service Candidates:

(i) The Regular In-service candidates shall be allowed to draw salary from the post against which they are posted.

(ii) For In-service Assistant Professors :- Salary, Pay Protection and other service conditions shall be governed as per provisions of Health & Family Welfare Department Letter No.6547/H Dt.04.03.2017.

(iii) The terms and conditions relating to Job responsibility and etc. of Asst. Professor on deputation basis will be guided as per the Clause-9 of Health & FW Resolution No.8967/H Dt.25.04.2022.

(iv) The engagement shall be purely temporary and on year to year tenure basis and may be for a maximum period of 04 years subject to satisfactory performance or till appointment of Doctor as Asst. Professor on regular basis through OPSC, whichever is earlier.

The selected candidates are requested to join immediately before the Prof. & HOD of their concerned Department after being relieved from their present place of posting.
