- (i) The Contractual candidates shall draw the remuneration against the post in which they are posted in MCH and remuneration as may be notified by the Govt. from time to time shall be applicable.
- (ii) Any additional incentive as may be notified by Govt. for the said post, shall also be applicable.
- (iii) The engagement shall be purely temporary on year to year tenure basis subject to satisfactory performance for a maximum period of three years.
- (iv) The selected candidates are requested to join within 7 days before the Prof. & HOD of their concerned Department.
- (v) Other terms and conditions as mentioned in the Govt. Resolution No.18582/H Dt.13.08.2020 shall be applicable.

Terms and conditions for In-service Candidates:

- (i) The Regular In-service candidates shall be allowed to draw salary from the post against which they are posted along with the additional incentive as notified by Govt. for the said post, shall also be applicable.

(ii) The engagement shall be purely temporary on year to year tenure basis subject to satisfactory performance for a maximum period of three years.

(iii) The selected candidates are requested to join immediately before the Prof. & HOD of their concerned Department after being relieved from their present place of posting.
