(iii) The engagement shall be purely temporary on year to year tenure basis subject to satisfactory performance for a maximum period of three years.

(iv) The selected candidates are instructed to report in the office of the undersigned and then submit their joining before the Prof. & HOD of the concerned Department within 07(seven) days from the date of issue of this order .
