Terms and conditions for Contractual Candidates:

- (i) The Contractual candidates shall draw the remuneration against the post in which they are posted and remuneration as may be notified by the Govt. from time to time shall be applicable.
- (ii) Any additional incentive as may be notified by Govt. for the said post, shall also be applicable.
- (iii) The engagement shall be purely temporary and on year to year tenure basis and may be for a maximum period of 04 years subject to satisfactory performance or till appointment/posting of Doctor as Asst. Professor on regular basis, whichever is earlier.
- (iv) Other terms and conditions as per the Clause-9 of Health & FW Resolution No.8967/H Dt.25.04.2022 shall be applicable.

The selected candidates are requested to join within 7 days before the Prof. & HOD of their concerned Department.

The selected candidates are requested to join immediately before the Prof. & HOD of their concerned Department after being relieved from their present place of posting.

**N.B: The selected candidates should mandatorily produce an affidavit from Notary along with the joining application mentioning the above terms and conditions and she should strictly follow the terms and conditions of the appointment order, failing which joining will not be accepted.**
