## **ADVERTISEMENT FOR THE POST OF ICU MEDICAL OFFICER FOR TRAUMA CARE CENTRE, SCB MEDICAL COLLEGE & HOSPITAL, CUTTACK ON CONTRACTUAL BASIS THROUGH WALK-IN-INTERVIEW**

Eligible candidates are invited to attend the walk-in-interview for the post of ICU Medical Officer for Trauma Care Centre, SCB Medical College & Hospital, Cuttack on 14.05.2025 (Wednesday) at 10 AM in the conference hall of the Superintendent on contractual basis in view of urgency. The details of the eligibility criteria, vacancies etc. are as under. The direct candidates shall be appointed on contractual basis. Applications in the prescribed proforma are invited from the eligible direct candidates for filling up the vacant post of 04 nos. of ICU Medical Officer for Trauma Care Centre, SCB MCH, Cuttack on contractual basis till the post is filled up on regular basis.

The engagement is purely temporary and the candidate cannot claim their right to continue in the post on the basis of such appointment/engagement. The selected candidates have to submit an undertaking to this effect.

1. **Number of Posts** - 4 nos. (Four)

2. **Reservation** : [S.C. – 1, S.T. – 02 (W-1), SEBC-01]  
(in case of nonavailability of reserve category, UR candidates may be considered).

3. **Monthly Remuneration**:

The remuneration will be Rs. 55,000/- (Rupees Fifty-five thousand) only per month with a hike of 3% in every year on satisfactory completion of one year of contractual service. (As per Govt. Resolution No.17390/H dt. 29.06.2018)

4. **ELIGIBILITY & QUALIFICATION**:

In order to be eligible for being engaged as ICU Medical Officer, the candidates must fulfill the following qualifications & eligibility.

**A) QUALIFICATION :-**

MBBS with completion of 1 year rotating internship.



**B) ELIGIBILITY:**

He/She must not be above 60 years of age as on 30.04.2025

**5. SCHEME OF SELECTION:**

- i. Selection will be strictly on the basis of merit list prepared on basis of career marks irrespective of the year of passing of the qualification examination. Weightage for different examinations shall be as under:-
  - a) MBBS - 40%
  - b) Intermediate/+2 Science - 20%
  - c) 10<sup>th</sup>/Matriculation - 20%
  - d) Personal interview - 20%
  - e) One mark will be deducted from the total career mark for each case of failure/extra attempt taken in the examination.
  - f) One mark will be added for each higher qualification.
- ii. Merit list will be prepared and approved by the constituted committee and appointment will be made on the basis of the interview on personal appearance and verification of the original documents.
- iii. The authorities have every right to cancel/change the schedule of appointment without assigning any reason.

**6. TERMS & CONDITIONS:**

- I. The post of ICU Medical Officer is purely non-practicing and if found to be indulged in any kind of private practice, their services will immediately be terminated by the appointing authority.
- II. The MO remaining absent unauthorizedly for more than 15 days will also be terminated by the authority.
- III. The appointing authority can terminate the tenure of MO by serving a notice of 30 days.
- IV. Before engagement the M.O. will execute a bond of judicial stamp paper worth of Rs. 100/- that they will not indulge in any kind of private practice/ litigation/ resort to strike/ cease of work/ bargain with Govt. for their continuance beyond the permissible period.
- V. Job chart will be issued by the Medical Superintendent.

**7. APPLICATION PROCESS:**

- b) The shortlisted candidates will be called for walk-in-interview through email ID / WhatsApp / Mobile Number to attend the interview at the office of the Superintendent on 14.05.2025 with all the original certificates and a photo copy of each document by 10 AM.

- c) This engagement is purely temporary and terminable at any time without notice or assigning any reason thereof.
- d) Application received after the due date and time/Incomplete application will not be accepted/entertained without assigning any reason.
- e) Candidates already in Govt. service/PSU are to apply through proper channel with a copy to the undersigned. Their application will be forwarded to the Govt. for considering as on deputation.
