**CORRIGENDUM NOTICE**

The following amendments /modifications are made with respect to TCN.No16485 dtd. 17.07.2025/SCB MCH, CUTTACK which may be read as follows:-

1. Sl.No.2.7-Tender for supply of Drugs & Medical consumables for the year 2025-26 reference no- 14685 dtd 17.07.2025 of SCBMCH, Cuttack.
2. Sl.No.3.12- Purchase order/ End user certificate from one or more competent authorities for each year from Govt/PSU Hospitals.
3. Sl.No.3.17- GSTR 3B & GSTR-1 on monthly basis for last one year 2024-25.
4. Sl.No.4.7 Omitted.
5. Sl.No.5.XV. Marketing experience/ End user certificate from one or more competent authorities for each year from Govt/PSU Hospitals.
6. Sl.No.6.1- Earnest money deposit of Rs.8,00,000/- (Eight Lakhs) only in shape of Demand draft from any Nationalized Bank/Scheduled Bank drawn in favour Superintendent,SCBMCH,Cuttack payable at Cuttack.
7. Sl.No.9.2- The tenderer should deliver the Drugs & Medical consumables at the consignee(Door delivery) at central store,SCBMCH,Cuttack.
8. Sl.No.9.6 The supply should be started immediately & completed within 15 days from the date of issue of the purchase order.If supply is not completed within 15 days from the date of issue of purchase order,the Suptd.SCBMCH,Cuttack may cancel the order or allow extension.
9. Sl.No.10.2- The Authority SCBMCH,Cuttack will also do random testing of the supplied drugs if required for which quality testing.
10. Sl no.10.3- If the drugs & Medical consumables as per report is found not of standard quality in first test,the suppliers will be required to replace the entire quantity of the batch declared NSQ or the cost of it in shape of bank draft in favour of Superintendent,SCBMCH,Cuttack payable at Cuttack & take back the available stock (unused) from Superintendent, SCBMCH,Cuttack within a period of 30 days of receipt of letter by Superintendent SCBMCH,Cuttack.
11. Sl.No.13- The Superintendent SCBMCH,Cuttack may allow extension on request of the firm for a maximum period of 15 days,after the stipulated date of supply i.e.15 days from the issue of purchase order which the penalty of 1% of purchase order value as Liquidated Damage.
